

## Application Guideline:

The criteria for awarding the grant would be based on the completion of the Application Form and other details, adhering to the guidelines and eligibility criteria mentioned below:

- The applicant (individuals or collectives) must be between the age of **25 to 40 years** at the time of the application submission, an India national residing presently and the past year in India.
- The work to be documented needs to be a new piece (previously not showcased) for performance in a non-proscenium, public space.
- The applicant must have practiced his/her discipline for about 3 years minimum, with 2 performances already done in the past.

- All completed application forms along with required documents and materials to be submitted online by the deadline to [grants@serendipityarts.org](mailto:grants@serendipityarts.org), via WeTransfer, Google Drive or Dropbox
- All completed application forms along with required documents and materials should be submitted to the online google application form as a single PDF file (no more than 20 MB).

### Application:

To apply please submit the following on our online portal by the **5<sup>th</sup> of June, 2019**:

- Completed application form
- A short portfolio illustrative of the applicant's present practice. This may consist of:
  - a) artwork, including photographs (no more than 10)
  - b) video links (no more than 4)
  - c) sound files (no more than 4, in MP4 format, transferred via WeTransfer or uploaded on Sound Cloud etc.)
  - d) a combination of the above where total number of items submitted are no more than 5

### Documents/ Materials to be submitted:

- Completed Application form
- A 500 word proposal from the applicant/collective detailing the performance to be documented as well as the kind of documentation requirement
- Portfolio
- Detailed budget
- Details of documentation team (if applicable)

### Selection Process:

- The deadline for the applications is **5<sup>th</sup> June, 2019**
- The selection of the Awardee would be based on a two-tier selection process. The first round of shortlisting will be based on the application, and the second round will be assessed by a Jury.

- The grant must be availed within 9 months of being awarded
- Announcement of the Grant Awardee: **15<sup>th</sup> July, 2019**

**Terms & Conditions:**

- The performance must be a new work, and not performed previously in an capacity
- A detailed break-up of the budget, along with the details of the documentation team must be shared with Serendipity Arts Foundation.
- There must be a mention of the documentation being supported by Serendipity Arts Foundation in the documentation, as well as in any capacity being shared on social media.
- Additional expenses, over and above the grant amount would be borne by the awardee.
- No relatives or extended family members of the Serendipity Arts Foundation team are eligible to apply for the grant.
- The awardee will be required to sign a Letter of Agreement to complete the selection process.

**Deliverables:**

The awardee on the completion of the grant must submit a copy of the video and stills of the documentation to Serendipity Arts Foundation for internal records and reports (not to be used without permission)

As an outcome the candidate could present the performance documentation at Serendipity Arts Foundation, New Delhi,
