Selection Process:

- The candidates will be selected based on a two-tier selection process. The first round of shortlisting will be based on the application, and the second round will be assessed by a Jury.
- The grant must be availed within 2 years of being awarded, 15th July, 2019 to 14th July, 2021
- Announcement of the Grant Awardee: 15th July, 2019

Terms & Conditions:

- This grant is applicable only for developing and showcasing a new piece.
- The documentation of the work in progress is to be submitted as part of the application.
- Additional expenses, over and above the grant amount will be borne by the awardee.
- Due credit to be given to Serendipity Arts Foundation in all publicity.
- INR 3,00,000/- will be given in two instalments, i.e. 70% after the selection process and 30% post showcasing the piece and on submission of the required documents.
- The awardee will be required to sign a Letter of Agreement to complete the selection process.
- No relatives or extended family members of the Serendipity Arts Foundation team are eligible to apply for the grant.

Deliverables:

- The awardee on the completion of the production must submit a report of 2000 words along with photo documentation of the performance.

- A digital copy of the documented performance to be submitted for SAF records. This documentation will not to be used elsewhere without permission
- Audited fund utilization certificate as per format provided for the total fund granted.
